Instrumental and Solo Singing Lessons 2021-22

Not only is there enormous musical and social enjoyment, artistic and expressive satisfaction, there is also a real sense of achievement which continues beyond school. Although it is a lengthy process which requires commitment and hard work, there will also be many occasions to celebrate and enjoy along the way, which make it richly rewarding.

1 Tuition Available

For pupils in Infant 1: only Piano, Violin, Recorder (as a gateway to other woodwind such as Clarinet /Flute).

For pupils in Infant 2: as for Infant 1 plus Cornet (as a gateway to other brass such as French Horn & Trumpet).

For all Junior/Senior pupils: Flute, Oboe, Clarinet, Saxophone, Bassoon, French Horn, Trumpet, Trombone, Tuba, Violin, Viola, Cello, Double Bass, Guitar, Drum Kit & Percussion, Piano, Organ, Singing.

2 Who will teach my child?

The majority of pupils will be taught by members of the visiting music staff. Such staff are private, self-employed teachers and will therefore, in all respects of fees (billed in advance), arranging of lessons and contractual matters, deal directly with parents. A number of pupils will be taught by members of the School's employed music staff as part of that teacher's allocation of lessons. In this case lessons are charged for (in arrears) on the termly school fee bill.

3 Time & Place of Lessons

All face-to-face lessons will take place either at the Saint Martin's campus (Preparatory School pupils) or in the David Turnbull Music School (Senior School pupils). Any remote lessons will take place via MS Teams and in accordance with the School's protocols for remote learning.

Most pupils will have their lessons on a rotational basis, meaning the lesson time will change from week to week. This is to enable us to accommodate the large quantity of pupils who take individual music lessons. Each week, Senior School pupils should write down the time of their lesson in their Planner/homework diary and also seek permission from their academic subject teacher at least 24 hours in advance. For Preparatory School pupils, instrumental teachers will liaise with both form tutor and parents to help support working within the rotational timetable. Fixed lessons are limited in availability and priority for fixed lesson times is given to:

- Pupils in Lower and Upper Sixth (lessons in private study periods or outside curriculum time);
- Pupils in Upper Fifth/Y11 (lessons outside curriculum time where possible);
- Pupils with identified additional learning needs, as required;
- Pupils learning more than one instrument (we make every effort to avoid pupils being timetabled for multiple instrumental lessons in curriculum time in any week).

4 Fees and Charges

Pupils will generally receive one 30-minute lesson weekly during term time. Over a whole year this is likely to total around 30 lessons. The music tuition fees will be reviewed annually (usually in the Summer Term) and may be increased by such amount as the governors consider necessary and reasonable. The rate for the 2021/22 academic year is £20.50 per half 30-minute lesson. Instrumental teachers reserve the right to suspend lessons in the event of non-payment by the due date. Additional costs for sundries, such as exams, sheet music, reeds, strings, etc. will be added to your child's school fee bill (in arrears).

5 Instruments and Insurance

Some orchestral instruments are available for hire by pupils (please see Instrument Hire Agreement on the back of the Application for Individual Music Tuition). Pianos, organs and percussion instruments are not available. All piano pupils need a piano at home, or regular access to one. All instruments brought into school should be insured by parents, including instruments on hire from the school or from an outside organisation. This can usually be done under the 'all risks' section of a general household insurance policy.

6 Lessons Missed

Lessons missed because of a pupil's absence will be charged for unless 24 hours' notice has been received. It is the pupil's responsibility to inform their music teacher of any absence, whether this is due to a planned school commitment or not. Scheduled lessons that are missed through a pupil's unplanned non-attendance will be charged for. In the case of staff illness, staff will endeavour to re-schedule the lesson or they will not charge. If the school is closed on a day in term time (e.g. for snow, lockdown), instrumental lessons may still take place via MS Teams.

7 Notice to Discontinue Lessons

Lessons may discontinue at the end of a school term by giving a term's notice. Notice to discontinue lessons must be given in writing (which includes email) to both the instrumental teacher and the Music Administrator by the end of the first week of the term in which tuition is to cease. Notice given later than this will be deemed to apply to the following term.

The only exception to this is in the first term of tuition; in this case, notice must be given by the fifth lesson of the first term of ten lessons, to stop after the tenth lesson.

During study leave, when pupils are only required on site for external exams, lessons will still continue but times should be negotiated between the pupil and the teacher. Pupils may opt in for face-to-face lessons as and when they can attend, and remote learning may also be possible in these circumstances. Continuing with creative music making is often a great way to balance academic revision.

8 Involvement in Ensembles

Joining an ensemble will help your child to become a better musician and develop important social skills. Membership of a group should be regarded as a fundamental part of their music education rather than an optional extra; your child will improve their sight reading and experience a greater range of repertoire. All pupils learning an instrument are also encouraged to be in a choir to aid aural development.

We are pleased to make available a number of orchestral instruments for hire by pupils at a charge of £25 per term. It is not intended that these instruments will be hired for a student's entire school career.

Hire costs are subject to annual review.

Insurance of hired instruments is the responsibility of parents. Parents may wish to check with their home contents insurance provider whether instruments need to be listed separately on their policy.

The hire agreement is valid for one year and can be reviewed with a view to extending the agreement for the following academic year at the discretion of the respective Head of Instrumental Section.

The hire fee is chargeable in arrears on the termly school fee bill.

We will supply the instrument in full working order and in good condition.

We expect that the hirer will take reasonable care to keep the instrument in full working order and in good condition at all times, and ensure that adequate insurance against damage and loss is in place.

The hirer is responsible for any loss or damage which exceeds reasonable wear and tear and will be invoiced accordingly if necessary.

Please inform the Music Administrator in writing as soon as the instrument is returned so that accurate accounts can be kept.
